Step 1 - Insert or swipe the international Visa card or MasterCard. The software will identify the home currency and convert it automatically.



Step 3 - The customer enters their PIN to process the Chip transaction or provides a signature to complete the swiped transaction.



Step 2 - The customer presses the corresponding key on the terminal to pay in their home currency or to pay in Sterling. The currency conversion rate is displayed at the top of the screen.



Step 4 - Complete the payment transaction and give your customer a copy of the receipt which shows the Sterling purchase price, the exchange rate and the final price in the cardholder's home currency*.
